#### VENDING 2020

The Lighthouse Quilt Guild wishes to invite you to participate as a vendor at our quilt show in 2020.

The quilt show will be August 15<sup>th</sup> and 16<sup>th</sup> with set-up scheduled for Friday August 14<sup>th</sup>. Our theme will be Butterflies and Bumble bees. The show will feature quilts, vendors, and public activity.

Vendor setup will be Friday, August 14<sup>th</sup> from 9 a.m. to 5 p.m. Please plan to arrive in plenty of time to prepare your area because we want to lock the doors at 5 p.m. Vendor booths are 10' X 10' and cost \$60.00 each; and, you may request more than one. If you have all your own setup equipment and don't want to rent tables, just indicate that on your entry form. Our location continues to be the fairgrounds.

The quilts will be judged by a certified judge for quality, appearance and workmanship. Ribbons will be awarded for 1<sup>st</sup> through 3<sup>rd</sup> place. Ribbons will also be provided for Best of Show and various other specialty awards, as well as a ribbon for the most popular quilt to be determined by the public.

The door prize drawings add a bit of levity to the show. We ask you to donate something for our door prizes and raffle. Crescent City does not have a local quilt shop.

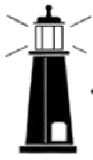
We do not permit closeout sales at our show. We don't feel it is fair to other participating vendors. You are welcome to give show discounts, etc.
